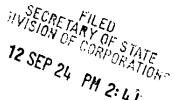

Purpose of Corporation: Americans for Responsible Advertising Inc. is a nonprofit research and educational organization
founded in Florida. Its purpose is to make Americans aware of the extent to which they are exposed to commercial
and noncommercial (e.g., political) advertising in general and to false, misleading, offensive, and abusive advertising in
particular. Americans For Responsible Advertising Inc. collects and analyses data on Americans' exposure to
advertising of all kinds and informs the American public of its findings. No substantial part of the Corporation's activities
shall consist of carrying on propaganda or otherwise attempting to influence legislation (except as otherwise
provided by Section 501(h) of the IRS code) and it shall not participate in, or intervene in (including the publishing
or distribution of statements) any political campaign on behalf of or in opposition to and candidate for public office.
The property of the corporation is irrevocably dedicated to educational purposes. Upon dissolution of the corporation
assets remaining after the payment of all debts and liabilities of the corporation shall be distributed to a nonprofit
fund, foundation, or corporation organized solely for educational purposes and tax-exempt under Section 501(C)(3) of the IRS Code.
No part of the earnings of the corporation shall inure to the benefit of, or be distributable to, its members,
officers, director, employees or other private persons except that the corporation shall be authorized
and empowered to pay reasonable compensation for services rendered and to make payments and distributions
in the furtherance of the purposes of the purpose set forth in these articles. Finally, and not withstanding any other
provision of these articles, Americans for Responsible Advertising Inc. shall not carry on any
other activities not permitted to be carried on by a corporation exempt from federal income taxes under
Section 501(c)(3) of the IRS Code or by a corporation the contributions to which are deductible under
Section 170(c)(2) of the Code.
