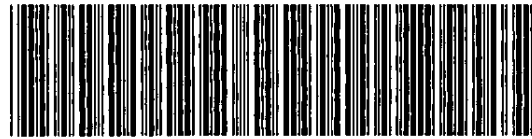

The name of this corporation shall be Life Unlived Ministries, Inc.


## Amendments Adopted


**Please amend Article 3 Purpose to read as follows:**
