ARTICLE I NAME

ARTICLE III PURPOSE

The purpose for which the corporation is organized is:

This corporation is organized exclusively for charitable, literary, and educational purposes as defined in section 501(c)(3) of the Internal Revenue Code. The purposes of the Corporation include raising funds and purchasing personal property and services to be used by students and faculty at North Marion Quarterback Club, Inc. providing volunteers for educational and extracurricular activities that will contribute to the public education of the community; engaging in other charitable, civic, or educational activities that will contribute to the public education of the community; and exercising other powers conferred by the laws of Florida on nonprofit corporations. This Corporation shall be self-governing, self-supporting, non-commercial, non-sectarian, nonprofit, and nonpartisan, and shall seek neither to direct the administrative activities of the Marion County School District nor to control its policies.

ARTICLE III(b) DISSOLUTION OF ASSETS Upon dissolution of the Corporation or the winding up of its affairs, the assets of the Corporation shall be distributed exclusively to charitable organizations which would then qualify under the provisions of Section 501(c)(3) of the Internal Revenue Code and its Regulations as they now exist or as they may be amended.

ARTICLE IV MANNER OF ELECTION The manner in which the directors are elected and appointed:

At the last general business meeting, officers are elected by a simple majority of the membership present.
