



ARTICLES OF INCORPORATION OF

A Florida Nonprofit Corporation

ARTICLE I

The name of the Corporation shall be "Lakeland Police Foundation, Inc."

ARTICLE II

The street address of the principal office of Lakeland Police Foundation, Inc. is

219 North Massachusetts Avenue Lakeland, (Polk County) Florida 33801

ARTICLE III

Said corporation is formed and organized exclusively for charitable, educational and scientific purposes under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code.

ARTICLE IV

The Directors of said corporation shall be elected or appointed as is stated in its bylaws.

ARTICLE V

No part of the net earnings of said corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered, confer benefits, and make payments and distributions in furtherance of the purposes set forth in Article III herein. The property of said corporation is irrevocably dedicated to the purposes set forth in Article III herein and no part of the net income or assets of said corporation shall ever inure to the benefit of any director, officer, or member thereof, or to the benefit of any private individual.

No substantial part of the activities of said corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate or intervene in, or publish or distribute the statements of any political campaign on behalf of, or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, said corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of Article III herein.

ARTICLE VI

Upon the dissolution of said corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of competent jurisdiction of the county in which the principal office of said corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
