

ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION

OF

LAKELAND POLICE FOUNDATION, INC.

1. Article III of the Articles of Incorporation of Lakeland Police Foundation, Inc., a Florida corporation, is hereby amended and restated to read as follows:

"ARTICLE III

Said corporation is formed and organized exclusively for charitable, educational and scientific purposes and preventing cruelty to children and animals under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code."

2. The foregoing amendment was adopted by the unanimous vote of the voting members of this corporation on October 17, 2019, which was sufficient for the approval of the amendment.
