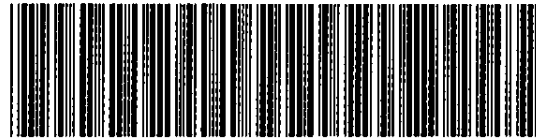

**ARTICLE I**

The name of the corporation is "Consumers for Impartial Courts, Inc." The principal place of business is: 338 North Magnolia Avenue, Suite B, Orlando, Florida 32801.

**ARTICLE II**

This corporation shall have perpetual existence.

**ARTICLE III**

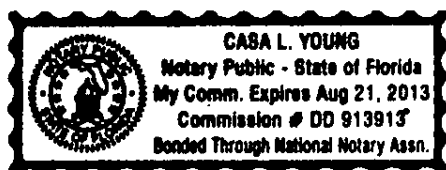

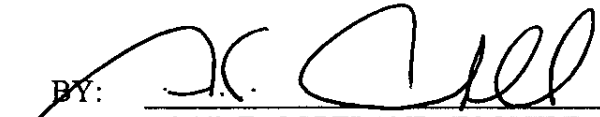
