

A.This Corporation is a non-profit Public Benefit Corporation and is not organized for the private gain of any person. It is organized under the Non-Profit public Benefit Corporation laws for.

The specific purpose of this corporation is intended to mend the souls of women victims of abuse, by working on their healing process of emotional trauma and also building strong support to stop the continuation of those abuses. We will offer support by way of counseling, vocational training, seminars and other resources in order to prevent future abuse. The corporation will empower and enrich the lives of low income women by teaching them practical principles that will break the generational cycle of depending on the government's welfare system and become self-sufficient citizens. Our foundation will help them maximize their potential through life enrichment skills that will enhance and direct their personal life styles, social awareness and career goals to engage society and marketplace values, while at the same time building their self-esteem. The Corporation will provide a safe environment to rescue, reconstruct and rejuvenate the minds bodies and souls of wounded women, youth, homeless, and the disadvantaged in the field of mentoring, tutoring, nutrition, vocational and obesity programs. We offer services and programs concerning anger management, crisis counseling, continuing education, domestic violence, teen pregnancy, battered women, and recidivism to help empower our community, with knowledge and resources to achieve greater self-identity, academic excellence, community involvement and balanced living to restore them to wholeness while preparing offenders to transition back into the community and be productive members of society. Literacy was chosen as a key ingredient for the program. Our program gives battered women and youth in our community a safe place to come and learn about life challenges in academic excellence by introducing principles and skills that increase their confidence and intellectual capabilities. The target group will comprise of pregnant teens, battered women, serious ex-offenders in the program of recidivism, children of domestic violence and incarceration to help combat literacy prevention, poverty, and homelessness prevention. The program target specific factors in each adult and family's environment (family, peers, and neighborhood) that contribute to anti-social behavior and developmental problems. Our program will also offer educational/after school enrichment programs in all areas. The program focuses on specific performance indicators with such measurable results as literacy research, rehabilitation, outreach activities, crisis counseling education, self-sufficiency values, pre-employment training, along with general anti-hunger and mental depression participation. The objective of the program is to improve self-sufficiency measures of good citizenship and personal accountability.
