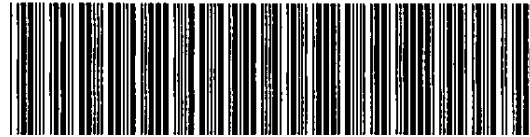



**Article I: Name of the Corporation**

**Article III: Purpose**

**ROJOE HOUSING AND RECOVERY** will exist exclusively for charitable, educational, and scientific purposes within the meaning of Section 501(C) (3) of the Internal Revenue code of 1986, as amended.

This corporation shall invest in the purchasing or rental of property in order to provide transitional living facilities and housing to low income recipients in need of emergency placement.

Provide a safe haven for those who want and need residential treatment for substance and alcohol addictions.

Services will also include holistic addiction treatment programs allowing a comprehensive Spirit-Mind-Body approach. Pro-active programs and outreach are provided to young adults who may be prone to behavioral problems that can lead to delinquency or imprisonment. In expansion efforts, the incorporation will obtain buildings to house all of its programs and to provide living facilities for its clients.

**ROJOE HOUSING AND RECOVERY** will provide meetings that offer a safe haven to young men, women and teens through the outlet of mentoring and organized activities that promote unity, responsibility, and educational development. Open discussions and activities will be provided that will develop character, morals and values. Leadership will be provided by successful executives, men, women, athletes, politicians and educators.

**ROJOE HOUSING AND RECOVERY** programs are designed to empower recovering substance abusers, disabled young adults as well as those who may have become subject to homelessness as well as those who may be seeking subsidized housing while recovering. We will also provide activities that promote positive self-esteem and self confidence, critical thinking skills, independence and self reliance, religious beliefs and foundations as well as social skills, etiquette, conflict resolution, self-direction and self-discipline

*Pursuant to the provisions of section 617.1006, Florida Statutes, the undersigned Florida nonprofit corporation adopts the following articles of incorporation:*

**ROJOE HOUSING AND RECOVERY** The facility provides clients with an eight-step program that teaches them necessary life skills. This collaborative approach to empowerment is the keystone to developing self-sufficiency in the clients. The steps include personal development, vocational training, substance abuse counseling, interpersonal skills building, community involvement, leisure activities, and independent living skills

**Article IV Registered Agent and Registered Office**

**Article V Indemnification and Limitation of Liability:**

1. The Corporation shall indemnify any officer or President or any former officer of the corporation, fully permitted by law. The private property of the member or officer, or president shall not, unless otherwise provided bylaw, be subject to the payment of the corporate debts to any extent whatsoever.
2. No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its member, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article III hereof.
3. No substantial part of the activities of the corporation shall constitute the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.
4. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code. This Corporation shall not discriminate in delivery of services based on race. Creed. Color, Culture, Sexual orientation, Financial or Economic Class or religious background or beliefs.

*Pursuant to the provisions of section 617.1006, Florida Statutes, the undersigned Florida nonprofit corporation adopts the following articles of incorporation:*

**Article VI Dissolution and Division of Assets**

Upon the dissolution of the corporation, assets will be distributed for one or more exempt purposes within the meaning of section 501(c) (3) of the Internal Revenue Code, or to other non-profit corporations for a public purpose. Any such assets not disposed of shall be disposed of by the Court of Common Pleas of the county in which the principal office of the organization is then located, exclusively for such purposes or to such organization or organizations, as the court shall determine, which are organized and operated exclusively for non-profit purpose.

**Article VII Manner of Election**

**Appointment of Officers:** The President and original founding members appoints Members of the Board of Directors and determines the number of directors that shall sit on the Board. Vacancies arising due to a terminating event shall remain unfilled until the next annual meeting with duties assumed by other members.

**Term of Office:** No maximum tenure for any one office on the Board of Directors exists.

**Removal from office:** The Board may remove a member of the Board of Directors for just cause.

**Article VIII Membership**

The membership shall represent neighborhood-based agencies, recipient neighborhoods and the community at large. Any charitable, scientific, health and educational agency may become a member as well as students enjoined to the programs provided by the corporation

**Article IX Officers**

The officers of the Corporation shall consist of the following: Chair of the Board of Directors, Executive Director, Secretary, Treasurer and such other officers as the President of the Board of Directors may designate from time to time.

**Article X Duration of Existence**

The corporation is organized on a non-stock basis and shall be considered established and in existence as of the date of receipt by the Department Of Incorporations. This corporation shall exist as a perpetual entity unless designated as otherwise by the President of the corporation.

**Article XI Amendments**

The Corporation reserves the right to amend or repeal any provisions contained in these Articles of Incorporation, or any amendment hereto, and any right conferred upon the members, partners or officers are subject to this reservation.


