

## ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF SOLARIS FOUNDATION, INC.



Solaris Foundation, Inc. hereby amends its Articles of Organization and states as follows:

- 1. The name of the corporation is Solaris Foundation, Inc. (document number N12000006392).
- 2. The Articles of Incorporation are hereby amended by deleting Article III in its entirety and replacing the said Article III with the following:

"The specific purpose for which this corporation is organized is to assist with the health and nutrition of Southwest Florida residents. This organization is organized exclusively for charitable, religious, educational and scientific purposes under Section 501(c)(3) of the Internal Revenue Code of 1986, as amended, or corresponding section of any future federal tax code. The corporation shall not take any action that is not permitted for an organization so organized.
