ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION SECRETARY OF STATE OF

These Articles of Amendment of H. Angela Whitman Foundation, Inc., a Florida not for profit corporation (the "Corporation"), are made as of this 9<sup>th</sup> day of August 2012. The original Articles of Incorporation were filed with the Department of State of the State of Florida on June 29, 2012. These Articles of Amendment have been duly executed and are being filed in accordance with Section 617.1006 of the Florida Not For Profit Corporation Act.

## 1. Article VI is amended to read as follows:

## ARTICLE VI Directors

The Corporation shall have three (3) directors. The number of directors may be increased or decreased from time to time and their election and appointment shall be as specified in the bylaws of the Corporation, provided that the Corporation shall always have at least three directors.
