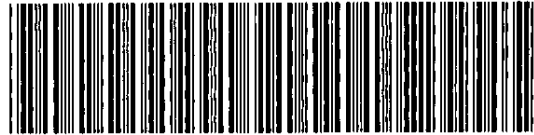

**Articles of Incorporation  
Of  
Intervention Ministries, Inc.**

The Undersigned Incorporator, a natural person 18 years of age or older, in order to form a corporate entity adopts the following articles of Incorporation.

**Article I**

**NAME OF ORGANIZATION**

The name of this corporation shall be Intervention Ministries, Inc. located at 5236 Bogdonoff Dr, Seffner, FL 33584

**Article II**

**PURPOSE**

This corporation is organized exclusively for charitable and educational purposes, more specifically to provide shelter for the homeless, food pantry, clothing assistance and free publications for homeless persons and community activities. To this end, the corporation shall at all times operate exclusively for charitable purposes within meaning of section 501 (c) (3) of the Internal Revenue Service Code of 1986, as now enacted or hereafter amended, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501 (c) (3) of the Internal Revenue Service Code of 1986, as now enacted or hereafter amended. All funds, whether income of principal, and whether acquired by gift or contributions or otherwise, shall be devoted to said purpose.

**Article III**

**EXEMPTION REQUIREMENTS**

At all times shall the following operate as conditions restricting the operations activities of the corporation:

1. The corporation shall not afford pecuniary gain, incidentally or otherwise to its members. No part of the net earnings of this corporation shall inure to the benefit of any member of the corporation, except that reasonable compensation may pay for services rendered to or for the corporation affecting on or more of its purposes. Such net earnings, if any of this corporation shall be used to carry the non profit corporate purposes set forth in Article II above.
2. No substantial part of activities of the corporation shall constitute the carrying on of propaganda or otherwise attempting to influence legislation, or initiative or referendum before the public, and the corporation shall not participate in, or intervene in (including by publication or distribution of statements), any political campaign on behalf of, or in opposition to, any candidate for public office.
3. Notwithstanding any other provision of the articles, the corporation shall not carry on any other activities not permitted to be carried on by a corporation exempt from federal income tax under section 501 (c) (3) on the Internal Revenue Code of 1986, as now enacted or hereafter amended.

**DURATION**

Upon the dissolution of the corporation or the winding up of its affairs, the assets of the corporation shall be distributed exclusively to one or more charitable, religious, or educational organizations which would then qualify under the provisions of Section

501(c) (3) of the Internal Revenue Service Code of 1986 and its regulations as they now exist or as they may be hereafter amended, or to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by the court of common pleas of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations as said court shall determine which are organized and operated exclusively for such purposes.


