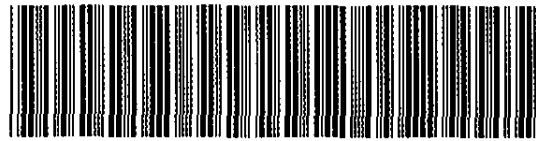

**ARTICLES OF INCORPORATION  
OF  
LIFE WITHOUT LIMITS MINISTRIES OF JACKSONVILLE, INC.  
(A Florida Not for Profit Corporation)**

The undersigned incorporator, a natural person competent to contract, hereby files these Articles of Incorporation in order to form a Not-for-Profit Ministry, to operate in accordance with the laws of God in a not-for-profit corporate form under and pursuant to the laws of the State of Florida, and for that purpose, does hereby adopt the following Articles of Incorporation.

**ARTICLE I. NAME OF CORPORATION**

The name of the corporation is LIFE WITHOUT LIMITS MINISTRIES OF JACKSONVILLE, INC. ("the Ministry")

**ARTICLE II. ADDRESS**

**PRINCIPAL OFFICE:** The principal office of the corporation is located at 159 Clark Road Jacksonville, Florida 32218

**MAILING ADDRESS:** The mailing address of the corporation is 3201 Dignan Street, Jacksonville, Florida 32254

**ARTICLE III. PURPOSE**

The objectives and purposes for which this Ministry is constituted and organized are:

1. Exclusively religious, charitable and educational with the meaning of section 501(c)(3) of the Internal Revenue Code or corresponding provision of any future United States Internal Revenue law.
2. To provide community ministry to counsel and help establish the Christian faith through the doctrines, teachings and information contained in the Holy Bible and derived from the historic Christian faith.
3. To act with charitable concern for and to help all men in need of any help which this ministry can give, regardless of race, gender, social position or religious affiliation.
4. To engage in such other businesses as may be approved by the Board of Trustees and which businesses are permitted by law within the meaning of section of 501(c)(3) of the Internal Revenue Code to further the purposes of the not-for-profit Ministry.

**ARTICLE IV. TERMS OF EXISTENCE**

This corporation shall exist perpetually unless dissolved according to law.

#### **ARTICLE V. OFFICERS**

The officers of the Ministry shall include a President, Vice-President and a Secretary/Treasurer. The Ministry may have additional officers, assistant officers and agents, as are determined by the Board of Trustees. The officers shall be elected, removed and hold office as provided in the Bylaws. The officers shall have such powers and responsibilities as provided by the Bylaws.

#### **ARTICLE VI. BOARD OF TRUSTEES**

The business and affairs of the Ministry shall be managed by the Board of Trustees, whose members are referred to herein as Trustees.

#### **ARTICLE VIII. BYLAWS**


