

ARTICLES OF INCORPORATION

OF

MORNING STAR RANCH OF SOUTH FLORIDA, INC.

A NON-PROFIT CORPORATION

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopts the following Articles of Incorporation:

ARTICLE I - NAME

The name of this corporation is Morning Star Ranch of South Florida, INC., a non-profit corporation.

ARTICLE II – PURPOSE

The purpose of the corporation is as follows:

- A. To support the provision of equestrian programs to promote physical, emotional, cognitive, psychological, social and leisure wellbeing of individuals with disabilities.
- B. To utilize the equestrian milieu to provide coaching, mentoring, counseling and life skills to disadvantaged individuals.
- C. To provide all services in a caring Christian atmosphere.
- D. This corporation is organized exclusively for charitable, religious, scientific, literary, and educational purposes, within the meaning section 501 (c) (3) of the Internal Revenue Code, or corresponding provision of any future United States Internal Revenue Law.

Notwithstanding any other provision of these articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from Federal income tax under section 501 (c) (3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Law.

In the event of dissolution, the residual assets of the organization will be turned over to one or more organizations whish themselves are exempt as organizations described in sections 501 (c) (3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Law.

ARTICLE III – DURATION

This corporation shall have perpetual existence.

ARTICILE IV – BOARD OF DIRECTORS

This corporation shall have not less than three and no more than seven directors. The initial directors shall be:

Membership shall be restricted to those persons who are residents of the United States of America and sho have demonstrated an interest in assisting charitable, non-profit and veterans organizations in carrying out the purpose of this organization. Members shall be admitted when approved by the Board of Directors.
