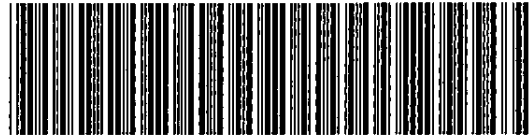

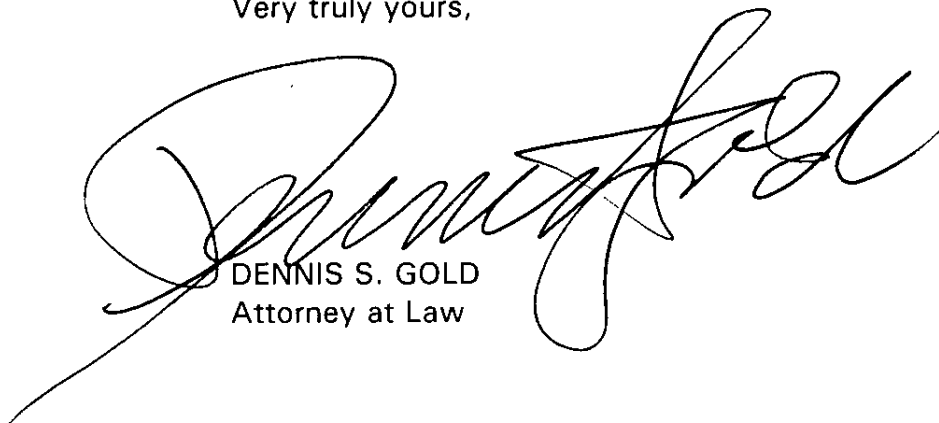

ARTICLES OF INCORPORATION

OF

SISTERS OF FAITH, INC.

A corporation not-for-profit

We, the undersigned, for the purpose of forming a Corporation not-for-profit under the Laws of the State of Florida, Florida Statutes 617, hereby adopt the following Articles of Incorporation.

ARTICLE I **NAME**

The name of this corporation shall be:

SISTERS OF FAITH, INC. - a corporation not-for-profit.

ARTICLE II **PURPOSE**

(A) The purpose for which this corporation is formed is:

A Christian outreach program of education and services to help the non-Christian faith members of the community in various ways so they can learn about the customs.

(B) To accomplish the foregoing purpose, the corporation shall carry out the following activities:

1. Organization, promotion and participation in activities involving non-Christian faith members.
2. Provision of assistance in every possible way with the education of non-Christian faith members.
3. Any other activity consistent with the foregoing and with the purpose of the Corporation, subject to the provisions of the Internal Revenue Code and its Regulations as they now exist or as they may hereafter be amended.
4. To establish and maintain offices for any and all operations of this corporation at such places to be determined by the directors, wheresoever the same may be located.

5. To do any and all things necessary, suitable and proper for the accomplishment of any of the purposes or for the attainment of any of the objects, or for the exercise of any of the powers herein set forth, whether herein specified or not, either alone or in connection with other firms, individuals or corporations, either in the State of Florida, throughout the United States or elsewhere, and do any other act or acts, thing or things, incidental or pertinent to or connected with the business hereinbefore described, or any part or parts thereof if not inconsistent with the laws of the State of Florida.
6. To engage in any activity or business permitted under the laws of the United States or of the State of Florida as permitted by Florida Statutes.

ARTICLE III **MEMBERS**

The first members of the Corporation shall be the persons subscribing to these Articles of Incorporation. Membership in the Corporation shall be open and granted to all persons and organizations exercising an interest in education and services to help non-Christians of the community.

ARTICLE IV **DURATION**

This corporation shall have perpetual existence.

ARTICLE X SEAL

The Corporation shall adopt a Corporate Seal meeting the requirements of governing law.

ARTICLE XI BY-LAWS

The initial By-Laws of the Corporation shall be adopted by the Board of Directors. The By-Laws may be amended from time to time in the manner provided for therein.

ARTICLE XII INDEMNITIES

The liabilities of the Corporation's officers, directors, employees and Agents is limited.

The Corporation shall have the power to fully indemnify its officers, directors, employees and agents as provided for in Florida Statutes Chapter 607. The determination regarding indemnity, as required by these Statutes, shall be made by the directors.

ARTICLE XII
DISSOLUTION OF THE CORPORATION

In the event that this Corporation shall be dissolved and its affairs brought to a close, the assets of the Corporation shall be distributed exclusively to such charitable organization which would at that time qualify under the provisions of Section 501(c)(3) of the Internal Revenue Code and its Regulations as they now exist or as they may hereafter be amended, as the directors in their complete discretion at the time of such dissolution shall determine.

ARTICLE ~~XIII~~ XIV
AMENDMENT OF ARTICLES OF INCORPORATION

These Articles of Incorporation may be amended by a two-thirds majority vote of the members present and voting at any meeting, provided that notice of the proposed action was included in the notice of the meeting not less than one month before the meeting.

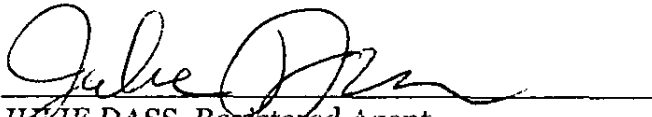
