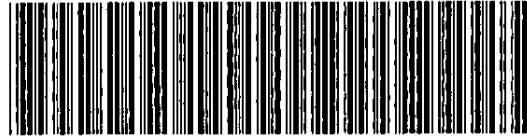

Section 617.0202(d), Florida Statutes, requires the manner in which directors are elected or appointed be contained in the articles of incorporation or a statement that the method of election of directors is as stated in the bylaws.

We need the manner of election for the directors not the officers. Why did you submit 3 applications with separate filing fees all under the same name?
