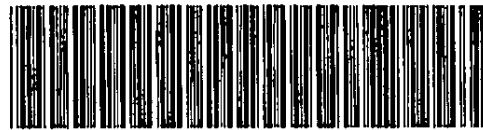

## **AMENDED AND RESTATED ARTICLES OF INCORPORATION**

LARGO HIGH SCHOOL IB PARENT PARTNERS, INC. (f/k/a

LARGO HIGH SCHOOL IB BOOSTER ORGANIZATION, INC.)

The **Largo High School IB Booster Organization, Inc.**, a Florida nonprofit corporation, pursuant to the provisions of section 617.1007, Florida Statutes, hereby amends and restates its Articles of Incorporation as follows:

### ARTICLE I – NAME

The name of this corporation shall be: **Largo High School IB Parent Partners, Inc.** (hereafter, the "Corporation").

### ARTICLE II – PRINCIPAL OFFICE

The principal address of the Corporation is:

### ARTICLE III-PURPOSE

This Corporation is organized exclusively for charitable and educational purposes, including (i) the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code and (ii) the support of the students, families, faculty and administration of the Largo High School IB Program, in each case in furtherance of charitable and educational purposes.

### ARTICLE IV – MANNER OF ELECTION

The manner in which the directors are elected or appointed is provided in the Bylaws of the Corporation.

### ARTICLE V – LIMITATIONS

No part of the net earnings of the Corporation shall inure to the benefit of, or be distributable to, its members, trustees, officers, or other private persons, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article III hereof. No substantial part of the activities of the Corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the Corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any

candidate for public office. Notwithstanding any other provision of these Articles, this Corporation shall not carry on any other activities not permitted to be carried on (i) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (ii) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

#### ARTICLE VI – DEDICATION OF ASSETS

Upon the dissolution, termination, or winding up of the Corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a court of competent jurisdiction of Pinellas County, Florida, exclusively for such purposes or to such organization or organizations, as said court shall determine, which are organized and operated exclusively for such purposes.

#### ARTICLE VII – REGISTERED AGENT

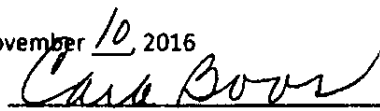
