ARTICLES OF INCORPORATION

A FLORIDA NOT-FOR-PROFIT CORPORATION

The undersigned citizens of the United States, desiring to form a not-for-profit corporation under the Florida Not-For-Profit Act, Chapter 617, Florida Statutes certify and acknowledge the following:

ARTICLE I-NAME

The name of the not-for-profit corporation shall be: **Viet Nam Vets/Legacy Vets Motorcycle Club, USA, State of Florida, Inc.**

ARTICLE II-PRINCIPAL OFFICE

The principal place of business address for the corporation is: 2425 La-Lar Lane, Pensacola, Florida 32534. The principal mailing address of the corporation is: 2425 La-Lar Lane, Pensacola, Florida 32534.

ARTICLE III-PURPOSE

The corporation is organized exclusively for charitable and educational purposes. The general nature and purpose of the corporation shall be the support of the various United States military veterans causes with respect to: (a) providing aid to the POW/MIA movement and educating the general public concerning POW/MIA facts and accountability issues, (b) providing, promoting and encouraging aid and assistance to all Viet Nam War era veterans as well as other veterans who served prior to 1962 and after 1975, (c) promoting patriotic and military historical dates of importance to our fellow community members, (d) aiding our country's Wounded Warriors from all wars in any way possible, (e) preserving and strengthening comradeship and brotherhood among its members, (f) perpetuating the memory and history of our military's dead, and (g) fostering true patriotism while maintaining and extending the institutions of American freedom, emphasizing the fact that "Freedom Is Not Free".

ARTICLE IV-DIRECTORS

The manner in which the directors/officers are selected is an election by the members of the corporation, as provided for in the by-laws of the corporation. In no event shall the number of officers be fewer than three.

ARTICLE V-DURATION/MEMBERSHIP

The period of duration of the corporation is perpetual. The qualification for members and the manner, of their admission shall be regulated by the Viet Nam Vets/Legacy Vets Motorcycle Club by laws.

ARTICLE VI-MEETINGS

After incorporation, the appropriate members of the corporation shall hold an organizational meeting, in accordance with Chapter 617, Florida Statutes, as amended. All meetings of the corporation shall be duly announced prior to the meeting. The minutes of each meeting shall be recorded and maintained by the officers in accordance with the by-laws.
