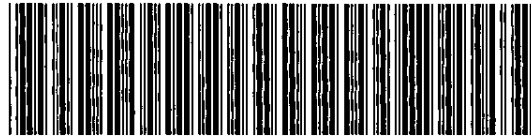

Article IX - Dissolution

As an exempt organization under section 501 (c) (3) of the internal revenue code, no part of the net earnings of the organization shall inure to the benefit, or be distributable to its members, trustee, officers, or other private persons. The organization shall be authorized and empowered to pay reasonable compensation for services rendered to third parties and distribution in the furtherance of the organization purpose. Upon dissolution, all assets, property and monies shall be distributed to an organization that meets the requirements of section 501 (c) (3) of the internal revenue code and no such assets, property or monies shall be used for any other purposes.

Article X - Conflict of Interest

The organization shall not enter into any transaction or arrangement that might benefit the private interest of any officer or director of this organization that violates the conflicts of interest policies as defined by the laws of the state of Florida or any applicable federal laws governing conflict of interest application to nonprofit and charitable organization. The Board of Directors shall adopt policies and procedures as appropriate and necessary to ensure the organization operates in a manner consistent with its charitable purposes and does not engage in activities that could jeopardize its tax-exempt status.


