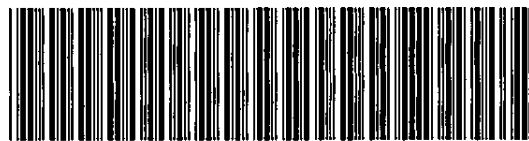

**ARTICLES OF INCORPORATION
OF
CHAKRA GIVES HOPE, INC
A FLORIDA NOT-FOR-PROFIT CORPORATION**

The undersigned, acting as Incorporator of a not for profit corporation under the Florida Not For Profit Corporation Act as set forth in Chapter 617 of the Florida Statutes, as amended adopts the following Articles of Incorporation for such Corporation:

ARTICLE I: NAME

The name of the Corporation shall be: Chakra gives Hope, Inc, hereinafter referred to as the "Comparator".

ARTICLE II: PRINCIPAL OFFICE AND MAILING ADDRESS

The address of the principal office is 8540 North Sherman Circle Suite 105 Miramar, Florida 33025. And the mailing address of the Corporation is 8540 North Sherman Circle Suite 105 Miramar, Florida 33025.

ARTICLE III: DURATION

The period of duration of the corporation shall be perpetual unless dissolved according to law.

ARTICLE IV: PURPOSES

ARTICLE V: RESTRICTIONS ON ACTIVITIES

No substantial part of the activities of this corporation shall consist of carrying on of propaganda or otherwise attempting to influence legislation, nor shall this corporation participate in or intervene in (including the publishing or distributing of statements) any political campaign on behalf of (or in opposition to) any candidate for public office.

ARTICLE VI: MEMBERSHIP

The Corporation shall be a non-membership.

ARTICLE VII:

The Corporations registered office shall be located at 8540 North Sherman Circle Suite 105 Miramar, Florida 33025, and Nancy B. Dormeus is the registered agent of the Corporation at that address.

ARTICLE VIII:

The number of Directors may increased or decreased from the time to time by an amendment to the by laws; however, there shall never be less than three Directors. 

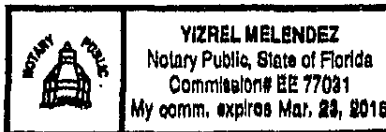


