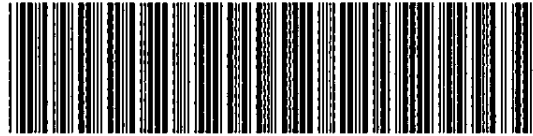

## ARTICLES OF INCORPORATION

Pursuant to Chapter 617.0202, F.S., (Not for Profit) the articles of incorporation of this corporation are:

### **ARTICLE I NAME**

The name of the corporation shall be: **HispanEduca, Inc.**

### **ARTICLE II PRINCIPAL OFFICE**

### **ARTICLE III PURPOSE**

The corporation is organized and shall operate exclusively for educational, information and charitable purposes within the meaning of section 501(c) (3) of the Internal Revenue Code of 1986, as amended. Specifically, the purpose for which the corporation is formed is to serve the lifelong education and information needs of the Hispanic population in all states and territories of the United States.
