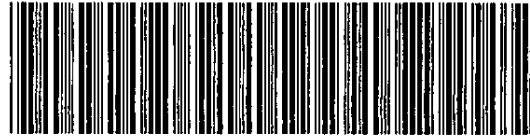

**Article I – Name**

The name of the Corporation shall be SHINE Homeschool Group, Inc.

**Article II – Principal Office**

The place in this state where the principal office of the Corporation is to be located is 15204 Leith Walk Lane, Tampa, Florida 33618, located in Hillsborough County.

**Article III – Purpose**

Said corporation is organized to provide support and educational resources to homeschool families, making it exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

**Article VI – Operations**

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article III hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, this corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of this corporation.

**Article VII – Dissolution of Assets**

In the event of dissolution of the corporation all liabilities and obligations of the group shall be paid, satisfied and discharged, or adequate provision made thereof. Any remaining funds as are in the treasury at the time shall be given to another organization exempt from taxation under Section 501(c)(3) of the Internal Revenue Code as amended, with preference given to another homeschool association that meets the Section 501(c)(3) requirements.
