ARTICLES OF INCORPORATION of Build Palm Beach County, Inc. (a nonprofit corporation)

The undersigned, a majority of whom are citizens of the United States, desiring to form a Non-Profit Corporation under the Non-Profit Corporation Law of the State of Florida, do hereby certify:

ARTICLE I- NAME

The name of this corporation is Build Palm Beach County, Inc.

ARTICLE II- PLACE AND ADDRESS

The place in this state where the principal office of the Corporation is to be located is the City of Riviera Beach, in Palm Beach County, Florida. The initial physical address shall be: Build Palm Beach County, Inc., 251 west 11th Street, Riviera Beach, FL 33404.

ARTICLE III-PURPOSE

- A. This organization is a nonprofit public benefit corporation and is not organized for the private gain of any person. Said corporation is organized exclusively for charitable, religious, educational, and scientific purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.
- B. The Specific purposes for which this corporation is organized include, but are not limited to: Build Palm Beach County, Inc. implements the YouthBuild program in Palm Beach County, Florida. The mission of Build Palm Beach County, Inc. is to unleash the intelligence and positive energy of young adults to rebuild their community and their own lives through a commitment to work, vocational training, education and community leadership development. The YouthBuild program is a comprehensive youth and community development program simultaneously addressing several core issues facing our community: education, housing, jobs, and leadership development.

ARTICLE IV- DIRECTORS OF THE CORPORATION

Directors shall be elected or appointed in the manner set forth in the bylaws of this corporation.

ARTICLE V-LIMITATIONS

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article Third hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code. Notwithstanding any other provision of these articles, this corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of this corporation.

ARTICLE VI- DISSOLUTION

Upon the dissolution of the corporation, no surplus remaining after payment of the just debts and liabilities of the Corporation shall be distributed to or amongst any members or directors of the Corporation, but after making provision for the payment of all of the just debts and liabilities of the Corporation, the remaining assets shall be distributed, as selected by the Board of Directors, for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such

organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
