Articles of Amendment: FARFAM FOUNDATION, INC. N12000007173

Add new Article: (Article X).

Article X. No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its incorporator, directors, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make reasonable payments and distributions in furtherance of its exempt purposes as set forth in these Articles.

Except as otherwise provided by the Code, no substantial part of the activities of the corporation shall consist of carrying on propaganda, or otherwise attempting, to influence legislation. The corporation shall not participate in, or intervene in (including the publishing or distributing of statements), any political campaign on behalf of (or in opposition to) any candidate for public office.

Notwithstanding any other provision of these Articles, the corporation shall not carry on any activities not permitted to be carried on (a) by a corporation exempt from Federal income tax under Section 501(a) of the Code as an organization described in Section 501(c)(3) of the Code, or (b) by a corporation contributions to which are deductible under Section 170(a) of the Code as being to an organization referred to in Section 170(c)(2) of the Code, or any subsequent federal tax code.

Notwithstanding any other provisions in these Articles, at all times when the corporation is deemed to be a private foundation within the meaning of Section 509 of the Code, it shall be subject to the following additional restrictions of this code or any future federal tax code:

- (a) The corporation shall make distributions for each tax year at such time and in such manner as not to become subject to the tax on undistributed income imposed by Section 4942 of the Code.
- (b) The corporation shall not engage in any act of self-dealing as defined in Section 4941(d) of the Code.
- (c) The corporation shall not retain any excess business holdings as defined in Section 4943(c) of the Code.
- (d) The corporation shall not make any investments in such manner as to subject it to tax under Section 4944 of the Code.
- (e) The corporation shall not make any taxable expenditures as defined in Section 4945(d) of the Code.
