

Article III should be amended to say the following: "This corporation is organized exclusively for charitable and educational purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code. More specifically, this corporation will empower young adults through live and online training, books and other products. All funds, whether income or principal, and whether acquired by gift or contribution or otherwise, shall be devoted to said purposes."

Add "Article IX - Dissolution Clause: Upon the dissolution of the organization, the Board of Directors shall, after paying or making provisions for the payment of all debts, obligations, liabilities, costs and expenses of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose."


