# Attachment to Articles of Incorporation of Donate Sweat, Inc.

Said organization is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under the section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code. The business activity for said organization is as follows: to provide worthy causes with financial and moral support through physical challenges that boost awareness for veteran and civilian charitable causes.
