PLAN OF DISTRIBUTION OF ASSETS

WHOLE FAMILY HEALTH CENTER FOUNDATION, INC.

Pursuant to the provisions of Section 617.1406(2) of the Florida Statutes, Whole Family Health Center Foundation, Inc., a Florida not-for-profit corporation, submits the following Plan of Distribution of Assets:

FIRST:

All liabilities and obligations of the corporation be paid and discharged, or

adequate provisions be made therefor.

SECOND:

Assets held by the corporation upon condition requiring return, transfer, or conveyance, which condition occurs by reason of the dissolution, be

returned, transferred, or conveyed in accordance with such requirements.

THIRD:

All of the remaining assets of the corporation are assets received and held by the corporation subject to limitations permitting their use only for charitable, religious, eleemosynary, benevolent, educational, or similar purposes, but not held upon a condition requiring return, transfer, or conveyance by reason of the dissolution. These assets are to be transferred to Whole Family Health Center, Inc., a domestic corporation engaged in activities substantially similar to those of the corporation,
