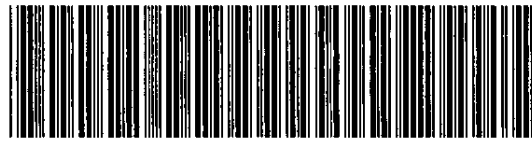

ARTICLE IV


DISSOLUTION

A plan of distribution of assets has been approved and attached hereto as Exhibit "A" and incorporated herein.



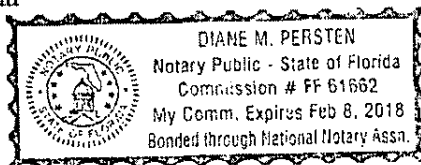


PLAN OF DISTRIBUTION OF ASSETS
