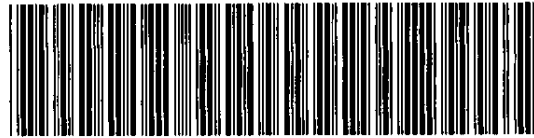

Articles of Incorporation of The Tallahassee Church Music Conference, Inc.
In Compliance with Chapter 617, F.S., (Not for Profit)

The undersigned, desiring to form a Non-Profit Corporation, do hereby certify:

Article 1

The name of the Corporation shall be The Tallahassee Church Music Conference, Inc.

Article II

Article III

The purposes for which this corporation is organized are:

1. To promote mutual understanding in the practice, theology, and philosophy of church music among Christians. *MA 10/14/2012*
2. To promote the research of and discourse on topics in church music.
3. To promote the dissemination of media springing from said research and discourse.

Said corporation is organized exclusively for charitable, religious, and educational purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

Article 4

The manner in which Directors shall be elected is as follows.

1. New members of the board of Directors shall be elected by a majority vote of the Directors.
2. The number of Directors shall not exceed nine.
3. The board of Directors shall have at a minimum the following officers: President, Secretary, and Treasurer.

The period of duration of this corporation is perpetual.

Article 9

The classes, rights, privileges, qualifications, and obligations of members of this corporation are as follows:

1. The Corporation will have no members

Article 10

The fiscal year of the Corporation shall run from July 1 to June 30

Article 11

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article Third hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, this corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of this corporation.

Article 12

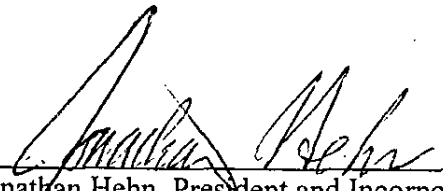
Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

Article 13

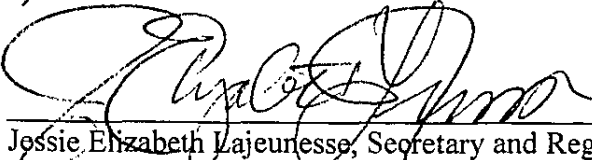
The operations of the corporation shall be governed by the Bylaws of The Tallahassee Church Music Conference, Inc.
