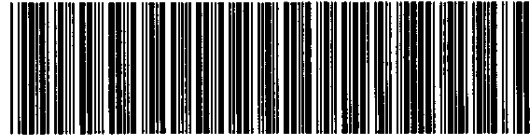

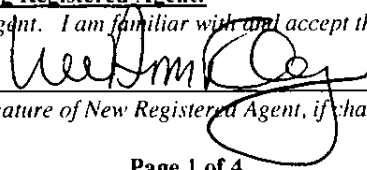

— Petit (Pettit). The Association may not attempt to influence legislation as any part —
— of its activities and it may not participate in any campaign activity for or against —
— political candidates. None of the net earnings of the Association may inure to the —
— benefit of any member. —

— Said organization is organized exclusively for charitable, religious, educational, —
— and scientific purposes, including, for such purposes, the making of distributions —
— to organizations that qualify as exempt organizations under section 501(c)(3) of —
— the Internal Revenue Code, or corresponding section of any future federal tax —
— code. —

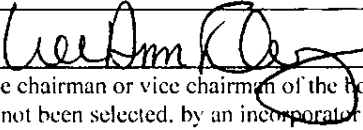
— Upon the dissolution of the corporation, assets shall be distributed for one or —
— more exempt purposes within the meaning of section 501(c)(3) of the Internal —
— Revenue Code, or the corresponding section of any future federal tax code, or —
— shall be distributed to the federal government, or to a state or local government, —
— for a public purpose. Any such assets not so disposed of shall be disposed of by —
— a Court of Competent Jurisdiction of the county in which the principal office of the —
— corporation is then located, exclusively for such purposes or to such organization —
— or organizations, as said Court shall determine, which are organized and —
— operated exclusively for such purposes. —
