## **Articles of Incorporation**

of

### Local Movement, Inc.

A Florida Nonprofit Corporation

Pursuant to the provision of the Nonprofit Corporation Act of the state of Florida, the undersigned incorporators hereby adopt the following Articles of Incorporation:

Effective Date 5-17 27, 2012

#### Article I

The name of this corporation is Local Movement, Inc.

#### **Article II**

The principal place of business address is:

1216 Banana River Drive Indian Harbour Beach, FL 32937

The mailing address of the corporation is:

#### Article III

- A. This Corporation is a not-for-profit corporation organized under Chapter 617 of the State of Florida Statutes. It is not organized for the private gain of any person. The specific purposes of this corporation are:
  - 1. To identify innovative ways to create and maintain a healthy community; covering the recreational health, social health, physical health, emotional health, economic health, and educational health of residents living in Central Florida.
  - 2. To create, execute, and promote programs, plans, processes, and awareness campaigns supporting the recreational, social, physical, emotional, economic, and educational health of the community.
  - 3. To support the initiatives of existing non-profits whose mission or purpose aligns with one or all areas of community health by partnering, fundraising, building community alliances, or offering resources.
- B. To exercise all rights and powers conferred by the laws of the State of Florida upon nonprofit corporations.

- C. Provided, however, that the corporation shall not engage in any action which is not permitted to be carried on by nonprofit corporations under the Internal Revenue Code and no part of the net earnings of the Corporation shall inure to the benefit of or be distributed to its officers or directors; but the Corporation shall be authorized and empowered to pay reasonable compensation to these people for services rendered, and to make payments and distributions in furtherance of its stated purpose.
- D. Said Corporation is organized exclusively for charitable purposes, within the meaning of Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code.
- E. Notwithstanding any other provisions of this document, the Corporation shall not carry on any other activities not permitted to be carried on (a) by an organization exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or (b) by an organization, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or corresponding section of any future federal tax code.

#### Article IV

This Corporation shall not have any members, voting or nonvoting, and is governed solely by its elected or appointed Board of Directors as provided for in the bylaws.

#### Article V

The Directors and Officers are elected as stated in the bylaws. The initial Board of Directors and Officers are:
