Article III - Purpose - Said corporation is organized exclusively for charitable, religious, educational, and
scientific purposes, including, for such purposes, the making of distributions to organizations that
qualify as exempt organizations under section 501(c) (3) of the Internal Revenue Code, or the
corresponding section of any future federal tax code and any related Internal Revenue Service
regulations as they now exist or as they may hereafter be amended. Said organization is further organized
to assist college students in their appreciation of music and dance performance through scholastic
