Notwithstanding any other provisions of these Articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from Federal Income Tax under Section 501 (c) (3) of the Internal Revenue Code, or corresponding provision of any future U.S. IRS Law, or (b) by a corporation contributions to which are deductible under Section 170 (c) (2) of the Internal Revenue Code or the corresponding provision of any future Federal Tax Code.

#### **ARTICLE IX DISSOLUTION**

Upon dissolution of the corporation, The Board of Directors shall, after paying or making provision for the payment of all liabilities and expenses of the corporation, the remaining asset shall be distributed to any other Not for Profit Organization with similar objectives which have qualified for exemption under Section 501 (c) (3) of the Internal Revenue Service Code. 
