### **ARTICLES OF INCORPORATION**

Incompliance with chapter 617,F.S., (Not for Profit)

### **ARTICLE III PURPOSE**

The purpose for which the corporation is organized is:

The purpose or purposes for which this corporation is organized are in accordance with s.617.0301,F.S. to promulgate the religious gospel and to promote the brotherhood of man under God, the father of all. This group of believers in Christ Jesus does hereby so organize itself. This group of believers will be governed in an orderly manner consistent with the principles of our faith and that the liberties inherent in each individual member of the church be preserved and the freedom of action of this body with respect to its relation to other churches of the same faith.

This corporation shall not be conducted or operated for profit, and no part of the net earnings of this corporation shall inure to the benefit of or be distributable to its members, trustees, officers or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make any payments and distributions.

The power to alter, amend, or repeal the bylaws or adopt new bylaws shall be in accordance with the bylaws of New Mount Zion Missionary Baptist Church of Hobe Sound, Inc.

Upon dissolution of the church in accordance with s.617.1406 (3) (c),F.S. the church shall after paying or making provisions for payment of all the liabilities of the Church, transfer assets to one or more churches designated by the church body which is of like faith.
