ARTICLES OF INCORPORATION OF CHAMPIONS CHRISTIAN FELLOWSHIP, INC.

The undersigned incorporator(s) for the purpose of forming a Florida not-for-profit corporation, under the provisions of Chapter 617 of the Florida Statutes, and as recognized under Section 501(c)(3) of the Internal Revenue Code, do hereby adopt the following Articles of Incorporation.

ARTICLE I NAME:

The name of the corporation shall be: Champions Christian Fellowship, Inc.

ARTICLE II PRINCIPAL OFFICE:

The principal office address and mailing address shall be: 882 High Pointe Circle
Minneola, FL 34715

ARTICLE III PURPOSE:

- 1. Said corporation is organized exclusively for religious, educational, charitable purposes within the meaning of Section 501(c)(3), including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future U.S federal tax code.
- 2. Champions Christian Fellowship, Inc. is organized to establish and maintain non-denominational churches as places of worship and learning for those who desire to fellowship and learn of the teachings of Jesus Christ as written in the Holy Bible; to build and maintain a unified body of persons who believe in the teachings of Jesus Christ as written in the Holy Bible and adhere to the faith in order to better promote the Gospel of Jesus Christ; to establish learning facilities, foundations, and help groups with the same non-profit purpose; to act with charitable concern, for members of this church and others; to ordain and license ministers upon completion of a prescribed course of study; to assist in the establishment and maintenance of other churches; to send forth missionaries for charitable purposes and the

establishment and up-building of other churches, both domestic and foreign; to communicate the gospel through mass media avenues and engage in all lawful activities related to the corporate purposes.

ARTICLE IV MANNER OF ELECTION/APPOINTMENTS:

The Chairman and/or Vice Chairman of the Board shall appoint each officer and/or member of the board of directors.

ARTICLE V OFFICERS/BOARD OF DIRECTORS:

The names and street addresses of the initial officers and/or directors of the corporation are as follows:

ARTICLE VI POWERS:

To the end that the foregoing objectives and purposes and any related religious and charitable purposes may be carried out, performed and accomplished, Champions Christian Fellowship, Inc., shall have the power to engage only in such activities as shall not constitute business unrelated to its religious, benevolent, charitable, literary purposes.

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers or other private persons, except that the corporation shall be authorized to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article Third, hereof.

No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing and distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.

Notwithstanding any other provisions of these articles, the corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of this corporation.

Subject to the foregoing limitations, and subject to the provisions of Section 617.021 of the Florida Statutes, Champions Christian Fellowship, Inc. shall have all rights and powers set forth in Section 617.021 of the Florida Statutes; to include, but not limited to raising funds for the purposes herein set forth, to acquire, own or lease, mortgage and dispose of both real and personal property; to conduct and carry on religious services and instruction through public media, including radio, telecasting, closed circuit transmission and cable television; to acquire, own and operate such broadcasting and/or telecasting facilities: and to accept donations for religious or charitable purposes.

ARTICLE VII DISSOLUTION:

If and when the corporation is dissolved, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to a government agency for a public purpose. None of the assets will be distributed to private individuals.

ARTICLE VIII REGISTERED AGENT/ REGISTERED OFFICE:

The location of the registered office of this corporation shall be 882 High Pointe Circle, Minneola, FL 34715, or at such other location as may, from time to time, be designated by the Board of Directors.
