ARTICLES OF INCORPORATION
OF

The undersigned subscribes to these Articles of Incorporation for the purpose of forming a corporation pursuant to the provisions of the Florida Not for Profit Corporation Act, Chapter 617, Florida Statutes.

ARTICLE I

The name of the corporation is "Voices of the Sunshine State, Inc." The principal place of business is: 135 South Monroe Street, Tallahassee, Florida 32301.

ARTICLE II

This corporation shall have perpetual existence.

ARTICLE III

The primary purpose for which this corporation is created and maintained shall be to conduct political activities as a "political organization" and to conduct one or more exempt functions under Section 527 of the Internal Revenue Code of 1986, as amended, and as permitted by the Florida Election Code.
