Pursuant to the provisions of section 617.1006, Florida Statutes, this Florida Not-for-Profit Corporation adopts the following amendment to its Articles of Incorporation replacing Article III of its Articles in its entirety with the Article set forth below. Furthermore, any article provisions contained in prior Articles of Incorporation that named and/or required the setting forth of the names of elected officers and directors are hereby deleted in their entirety.

ARTICLE III. PURPOSE

The Corporation is organized for and shall be operated exclusively for charitable, cultural and educational purposes within the meaning of section 501(c)(3) of the Internal Revenue Code of 1986, as amended, and the regulations promulgated and rulings made thereunder (the "Code"). The Corporation's purpose shall include, but not be limited to, addressing racial, economic, and sexual oppression through personal and cultural transformation.

In furtherance thereof, the Corporation may receive property by gift, devise or bequest, invest, and reinvest the same, and apply the income and principal thereof and engage in any lawful act or activity for which corporations may be organized under the Florida Not for Profit Corporation Act.

In furtherance of its exclusively charitable purposes, the Corporation shall have all the general powers enumerated in Section 617.0302 of the Florida Not for Profit Corporation Act as now in effect or as may hereafter be amended together with the power to solicit grants and contributions for such purposes.
