

### AMENDMENTS TO ARTICLES OF INCORPORATION OF CORONAS PARK HOMEOWNERS ASSOCIATION, INC. (the "Articles")

## ARTICLES OF INCORPORATION OF LA LINDA SIESTA KEY ESTATES CORONAS PARK HOMEOWNERS ASSOCIATION, INC.

#### **ARTICLE I. NAME**

The name of the Corporation shall be <u>CORONAS-PARKLA LINDA SIESTA KEY</u> <u>ESTATES</u> HOMEOWNERS ASSOCIATION, INC., a Florida Corporation Not-For-Profit (hereinafter the "Association").

### ARTICLE III. PURPOSE

The general purpose of the Association shall be as follows: to be the "Association," for Coronas Park Subdivision (hereinafter referred to as "Subdivision") as that term is defined in the Declaration of Covenants. Conditions and Restrictions For Lots in Coronas Park, recorded at Instrument No. 2008100212 of the public records of Sarasota County, Florida, as amended from time to time (hereinafter referred to as the "Declaration"), situated on Siesta Key, Sarasota County, Florida and to operate and administer said Subdivision and carry out the functions and duties of said Subdivision, as set forth in the Declaration establishing said Subdivision and Exhibits annexed thereto.
