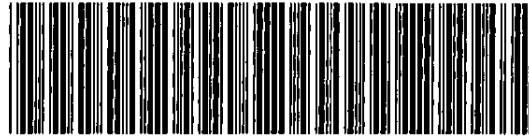

ARTICLE I – NAME

The purpose for which the corporation is organized is:

- (a) Sarasota BCS Festival 2014, Corp. is organized exclusively for charitable purposes as specified under Section 501(c)(3) of the Internal Revenue Code to educate the public about breast cancer in a positive, proactive way through the sport of dragon boating to serve as role models; to mentor those newly diagnosed with breast cancer; and to promote a healthy, active lifestyle and provide organized opportunities for physical fitness, wellness education, and psycho-social empowerment among breast cancer survivors.
- (b) No part of the net earnings of the organization shall inure to the benefit of, or be distributable to, its directors, trustees, officers, or other private persons except as specified in subsection (a) above. This corporation shall only engage in activities lawfully authorized for not-for-profit corporations, as established under Section 501(c)(3) of the internal Revenue Code of 1954, as amended or as same may be amended from time to time.
- (c) This organization will not participate in any political campaigns nor influence legislation.
