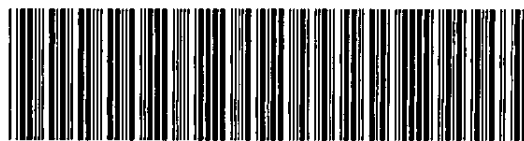

ARTICLES OF INCORPORATION

ARTICLE 1

The name of the corporation shall be Sarasota Masonic Lodge No. 314, Inc.

ARTICLE 11 PRINCIPAL OFFICE

ARTICLE 111 PURPOSE

The Corporation is organized exclusively for charitable, religious, educational and Masonic purposes, including, for such purposes, the making of distribution to organizations that qualify as exempt under Section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future tax code. Such purpose shall include but not be limited to producing educational, community-oriented publications and related educational activities.

ARTICLE 111A DISSOLUTION

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the Masonic Grand Lodge, PHA, or the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of by a Court of Competent jurisdiction of the County in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.




