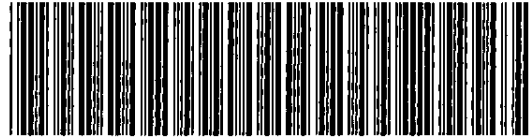

ARTICLES OF INCORPORATION  
OF

The undersigned subscriber to these Articles of Incorporation is a natural person competent to contact and hereby form a Non-Profit Corporation under Chapter 617 of the Florida Statutes.

ARTICLE I - NAME

The name of the Corporation is: Yong Qiang Ryo, Inc.  
(hereinafter "Corporation")

ARTICLE II - PRINCIPAL OFFICE

The principal place of business and mailing address of this Corporation shall be: 9760 65th Way N., Pinellas Park, Florida 33782

ARTICLE III - PURPOSE OF CORPORATION

Said corporation is organized exclusively for charitable, educational and scientific purposes, including, but not limited to such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code. Further purpose to teach, education and assist individuals with options for home based business through alternative product choices as it relates to same.

ARTICLE IV - PROHIBITIONS

Notwithstanding and other provisions of these articles, the Corporation shall not carry on any other activities not permitted to be carried on (a) by a Corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a Corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

ARTICLE V - MANNER OF ELECTION & INITIAL DIRECTORS

The Directors shall be elected and or appointed in accordance with the By-Laws of the Corporation. The Initial Directors of the Corporation shall be:
