

ARTICLES OF INCORPORATION OF PRINCE OF PEACE MORAVIAN CHURCH FOOD PANTRY Corporation

The undersigned, acting as the incorporator for the purpose of forming a corporation in compliance with Florida Statutes, Chapter 617, hereby adopts the following Articles of Incorporation for such Corporation:

ARTICLE 1 NAME
