ARTICLE 1 NAME

The name of the corporation shall be: BAY COUNTY OYSTERMEN'S ASSOCIATION, INC.

ARTICLE 2 PRINCIPAL OFFICE

The street address of the principal office of the corporation is: 3064 NW McClain Ln, Altha, Florida 32421.

ARTICLE 3 PURPOSE

This corporation is organized and operated exclusively for one or more of the following purposes pursuant to section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code-Charitable, Scientific and/or Educational purposes-including for such purposes, the making of distributions to organizations that qualify as exempt organizations under 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

This corporation has not been formed for the making of any profit, or personal financial gain. The assets and income of the corporation shall not be distributable to, or benefit the trustees, directors, or officers or other individuals. The assets and income shall only be used to promote corporate purposes as described below. Nothing contained herein, however, shall be deemed to prohibit the payment of reasonable compensation to employees and independent contractors for services provided for the benefit of the corporation. The corporation is organized exclusively for charitable and educational purposes. campaign in any manner. The corporation shall not attempt to influence legislation. The corporation is organized exclusively for charitable, scientific, and educational purposes.

The specific purposes for which this corporation is organized are to support Bay County Oystermen, and their families as possible when the bay is closed to harvesting due to causes beyond their control, to promote the improvement of working conditions for oystermen in Bay County, to promote good conservation practices in and for the waters of Bay County Florida, to protect, preserve, and enhance the shellfish harvesting areas of Bay County Florida, to promote the sale of seafood including shellfish harvested from the waters of Bay County Florida and to promote cooperation between oystermen and all others who earn their livelihood on and from the waters of Bay County Florida.
