The undersigned, acting as the incorporator of a corporation pursuant to Chapter 617 of the Florida Statutes, the Florida Not For Profit Corporation Act, adopts the following Articles of Incorporation for such corporation:

Article 1

The name of the corporation is Christians for Missions, Inc.

Article 2

The principal place of business of this corporation is:

1140 66th Avenue
Vero Beach FL 32966

Article 3

The corporation is organized exclusively for charitable and religious purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986 (or corresponding provision of any future United States Internal Revenue law) and engaging in any other activity not prohibited to corporations under the Florida Not-For-profit Corporation Act that is in furtherance of its tax exempt purposes.

Article 4

The affairs of the corporation shall be conducted by the board of the directors of the corporation. The method of election of directors shall be stated in the Bylaws. The corporation shall have a minimum of three (3) directors. The names and addresses of the initial officers of the corporation are:

Article 5

No part of the net earnings of the corporation shall inure to the benefit of or be distributable to its members, directors, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the tax-exempt purposes of the corporation set forth in Article 3.

Article 6

Upon the dissolution of the corporation, the Board of Directors shall, after paying or making provision for payment of all the liabilities of the corporation, distribute all of the assets of the corporation to organizations organized and operated exclusively for charitable, religious, or educational purposes under Section 501(c)(3) of the Internal Revenue Code of 1986.

Article 7

No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.

Article 8

The street address of the initial registered office of the corporation is 1702 Club Drive, Vero Beach, FL 32963, and the name of the initial registered agent of the corporation at the initial registered office is James A. Schorner.

Article 9

The corporate powers of this corporation are as provided in section 617.0302, Florida Statutes, except that the corporation shall not carry on any activities not permitted to be carried on by an organization exempt from Federal income tax under Section 501(c)(3) of the Internal Revenue Code of 1986 or by an organization, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code of 1986

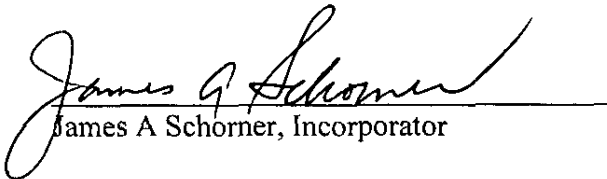

Article 11

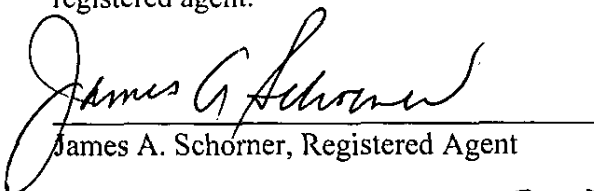
The corporation shall be effective on September 1, 2012 or such later time as approved by the Florida Secretary of State and its period of the duration is perpetual unless dissolved according to the law.
