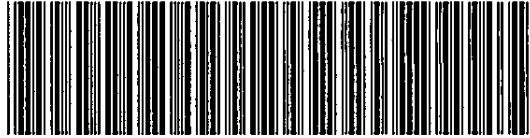

The Articles of Incorporation of

The undersigned, for the purpose of forming a Not-For-Profit corporation under the laws of the State of Florida, do hereby adopt the following Articles of Incorporation.

**ARTICLE I**  
**NAME**

The name of the corporation shall be **Miracle Baptize Holiness Church of God of The America Inc.** (hereinafter called the ("Corporation")).

**ARTICLE VII  
DISSOLUTION**
