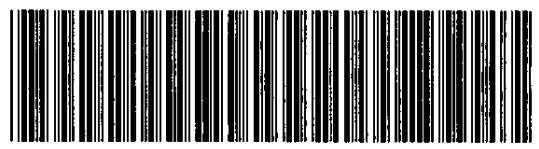

The text of each amendment adopted is as follows: The purpose of this amendment is to include from Article number III in the original Articles of Incorporation, the following verbiage: Said organization is organized exclusively for charitable, religious, educational and scientific purposes including for such purposes, the making of distributions to organizations that qualify as exempt under Section 501 (c)(3) of the Internal Revenue Code or the corresponding section of any future federal tax code.

This amendment is also to include the following verbiage as Article number VIII in the original Articles of Incorporation: Upon dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be disposed of by a Court of Competent Jurisdiction of the country in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

This amendment is also to include an Article number IX, that is the current Article number VIII in the original Articles of Incorporation which is regarding the effective date of the corporation.
