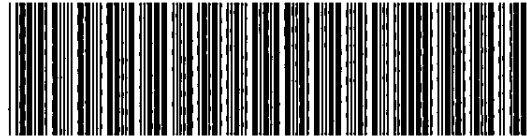

ARTICLE I NAME

ARTICLE III PURPOSE

A. The purposes for which the Women Pastors Alliance of South Florida is organized are exclusively religious, charitable, scientific, literary, and educational within the meaning of section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Law. We, the Women Pastors' Alliance, set forth to accomplish as God Allows: linking ourselves together to complement one another, to relegate not to the background the call of God, but to stand in dignity and integrity without compromising our position, yet not moving in any way over the boundaries which God has set for us. To aid the Brotherhood, our local Assemblies, General Assemblies and our Holy Convocations all without intimidation or rebellion seeking the will of God in Christ Jesus concerning us. Joining the Cloud of Witnesses: ("Great Women of God") who have gone before us, therefore we gather in this quest for instructions, directions, building up for birthing and conferencing together.

B. Notwithstanding any other provision of these articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from Federal income tax under section 501 (c)(3) of the Internal Revenue Code of 1988 or the corresponding provision of any future United States Internal Revenue Law.

C. In the event of dissolution, the residual assets of the organization will be turned over to one or more organizations which themselves are exempt as organizations described in sections 501(c)(3) and I 70(c)(2) of the Internal Revenue Code of 1986 or corresponding sections of any prior Or future Internal Revenue Code, or to the Federal, State, or local government for exclusive public purpose.
