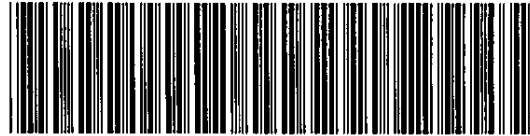

provision of any future United States Internal Revenue law.

Article IX Upon the dissolution of the organization, assets shall be distributed for one or more
exempt purpose within the meaning of section 501(c)(3) of the Internal Revenue Code of
1986 or corresponding section of any future United States Internal Revenue law or shall be
distributed to the Federal, state or local government for a public purpose. Any such assets
not so disposed of shall be disposed of by a court of competent jurisdiction of the county in
the principal office of the organization is then located, exclusively for such purposes.


