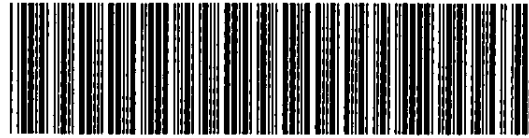

ARTICLE I NAME

ARTICLE III PURPOSE

The purpose for which the corporation is organized is:

1. To conduct all lawful business commonly conducted by a 26 USC § 527 political organization, including but not limited to engaging in political action in the State of Florida and serving as an affiliate organization of the Libertarian Party in national politics;
2. To implement and give voice to the principles embodied in the Statement of Principles adopted by the Libertarian Party of Florida;
3. To recruit and support candidates for state and federal offices, and to promote, charter and coordinate county affiliate parties within the State of Florida to do the same;
4. To transact any other lawful business which not for the profit corporations may transact under the Florida Not For Profit Corporation Act, chapter 617, Florida Statutes, in connection with or auxiliary to accomplishing the foregoing political purposes.

ARTICLE IV MANNER OF ELECTION

The manner in which the directors are elected and appointed:

The Chair, Vice-Chair and odd numbered Directors-at-large shall be elected in odd numbered years. The Secretary, Treasurer, and even numbered Directors-at-large shall be elected in even numbered years. Regional Representatives shall be elected at the Annual Business Meeting and shall serve for a period of one (1) year.
