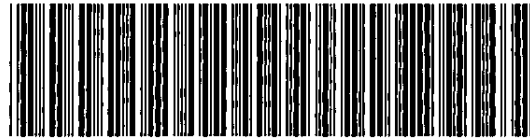

Article I: Name

Article II: Principal Office

Article III: Purpose

(A) This corporation is organized exclusively for charitable, religious, and educational purposes, including for such purposes as raising funds, to request and receive grants, gifts, contributions, or any other objects real and personal property. And in the making of distributions to other families and organizations which meet this corporations charitable requirements.

(B) No part of the net earnings of this organization shall be to the benefit of, or be distributed to its members, officer, or other private persons, except that the organization shall be authorized and empowered to pay reasonable compensation for furtherance of the purposes set forth in the purpose clause hereof. No substantial part of the activities of this organization shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and this organization shall not participate in, or intervene in (including the publishing or distributing of statements) any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of this document, the organization shall not carry on any other activities not permitted to be carried on (a) by an organization exempt from federal income tax under section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or (b) by an organization, contributions to which are deductible under section 170 (c) (2) of the Internal Revenue Code, or corresponding section of any future tax code.

(C) Upon the dissolution of this organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for the public purpose. Any such assets not disposed of shall be disposed of by the Court of Common Pleas of the county in which the principal office of this organization is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.




