## 1. Article III, Purpose - Add additional paragraph:

The Senior Activity Center of Sebastian is organized exclusively for charitable, religious, educational and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or corresponding sections of the federal tax code.

# 2. Article IV, Manner of Election - Add the sentence:

A majority of the Executive officers shall be year round full-time residents of the City of Sebastian.

# 3. Add Article VIII- Distribution of Earnings

No part of the net earnings of the Corporation shall inure to the benefit of, or be distributable to its members, trustees, officers or other private persons, except that the corporation/Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in the furtherance of section 501(c)(3) purposes. No substantial part of the activities of the Corporation shall be carrying on of propaganda, or otherwise attempting to influence legislation, and the Corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.

# 4. Add Article IX - Limitation of Corporate Activities

Notwithstanding any other provision of these articles, the Corporation shall not carry on any other activities not permited to be carried on (a) by a Corporation exempt from Federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a Corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future tax code.
